



CARE WORKER SLAMS PLYMOUTH TAXI FIRMS OVER LACK OF WHEELCHAIR ACCESS

A care worker has criticised taxi companies for failing to provide enough wheelchair accessible vehicles at weekends.

Sabrina Jones looks after a severely disabled woman who relies entirely on adapted taxis to get around.

Mrs Jones, who said she could not give any details of her client, said: "I think this is discrimination against disabled people not being able to access the community."

'DON'T BLOCK THE DROP' Campaign

Disabled Motorist UK is proud to be supporting Disabled GO with their new '**Don't block the Drop**' campaign. The aim of this campaign is to stop motorists parking in front of dropped kerbs. When these kerbs are blocked it can cause huge problems for some disabled people who need dropped kerbs to get off the road and out of the path of oncoming traffic.

The company plans to collect **1,000 examples** of '**drop blockers**' over an eight week period so they are calling for anybody who has seen a vehicle parked in front of a dropped kerb to send their evidence in to:

Peers Defer to Elected Commons on Cuts to Employment & Support Allowance (ESA)

Peers backed down in their battle with MP's over cuts to disabled peoples' benefits. Ministers claimed because the cut involves money they have "financial privilege" and asserted the Commons' right to have the final say on budgetary measures.

The government was defeated twice in the House of Lords over their proposed cut of £30 a week to ESA for new claimants in the Work-Related Activity Group (WRAG) from April 2017. This will bring the rate in line with Jobseeker's Allowance, reducing weekly from £102.15 to £73.10, a £1,500 a year reduction

Ministers argue that this cut will be an incentive to return to work. Peers wanted an impact assessment on the health, finances and work prospects of claimants and campaigners say the cut will push claimants further into poverty.

Baroness Campbell said: "I hope and pray that we don't look back on this day as the moment we pushed some of the most severely disabled people in Britain over the edge."

"I think we all know deep down inside that it is attitudinal and environmental discrimination that really prevents this group from accessing employment."

Maximus & Work Capability Assessments

How are Maximus faring with the contract for the Work Capability Assessment?

In March 2015 Maximus took over delivery of the Work Capability Assessments from Atos.

On the 8th January 2016 the Guardian reported on disclosures made by official auditors about Maximus's performance. They are performing worse in the implementation of fitness-to-work tests in key areas and costs continue to spiral. DPAC (Disabled People Against Cuts) says very little is expected to change with this transfer to another large private company and calls for the Work Capability Assessment to be scrapped and benefit tests to be brought back within the public sector.

ESA targets were 7 weeks from assessment to receiving a benefit. In August, this figure was revised to 23 weeks the report said. The average time to process ESA claims has been cut from 29 to 23 weeks but there remained a backlog of 280,000 in August.

Scope Plymouth

SCOPE provide support, information and advice services to disabled people and opened new service in Cornwall Street in January this year.

I spoke to Amy Gunther, Manager about what is on offer from this new service. Amy explained that a Day Service operates from their new base with activities in and out of the Centre and they are offering **Taster Days**. She told me that SCOPE supports disabled peoples' access to mainstream opportunities by working with local businesses and organisations to ensure the activity is accessible.

If you are interested SCOPE can carry out an assessment to find out about your interests and access needs and provide an Enabler to support you. The service is not free, staff will discuss payment options with you if you want to use it. You can pay using direct payments, personal budgets, private income or through the local authority. The Day Service costs £46 per day.

Disability Discrimination by Department of Work & Pensions (DWP)

Graham Kirwan has been told that he is unable to communicate via email to claim Personal Independence Payment (PIP). Kirwan was a long-term claimant of Disability Living Allowance (DLA), but his payments were suspended when he failed to respond to letters asking him to apply for PIP, letters that he says he never received and that would not have been accessible to him anyway.

Graham is partially-sighted and has computer software that magnifies text, but it does not generally work with scanned or PDF documents. He has been told by the DWP to use the charity Citizens Advice to help with his PIP application but he wants to fill in the form himself, so he can take responsibility for the accuracy of the answers.

DWP guidance states that email is an acceptable alternative for communication for people with a visual impairment.

Graham represents Dudley Centre for Inclusive Living on accessible information issues. He has already secured one legal victory over a government department, after a threatened judicial review led to the Department of Health publishing its first accessible information standard earlier this year.

Plymouth ‘Dementia Friendly’ parking spaces

Following consultation with carers Plymouth City Council’s parking unit has introduced new dementia accessible parking spaces in two of its car parks. This does not affect Blue Badge spaces.

The Council has made changes to signage and allocated two designated ‘dementia friendly’ spaces in both Western Approach and Theatre Royal car parks. The spaces are on entry level and close to the ticket machines and pedestrian exits.

Councillor Brian Vincent, Cabinet Member for Streetscene for Plymouth City Council, said: “We aim to make our car parks as accessible as possible and we are delighted to be able to introduce this new scheme in Plymouth.”

Your experiences of using hackney carriage vehicles in Plymouth

CTS Traffic & Transportation have been appointed by Plymouth City Council taxi licensing to review their current policy of limiting hackney carriage vehicle numbers.

As part of this independent review CTS would like to hear from anyone wishing to share their experiences of using hackney carriage vehicles in Plymouth – both great and not so great – and particularly to give them the opportunity to say how they think the current fleet meets their specific travel needs.

They are aware that people tend to use a mix of hackney carriage and private hire; these experiences may cover both kinds of vehicle, and bookings by telephone as well as taking vehicles at ranks or in the streets.

They are particularly interested in the personal access experiences or difficulties that disabled people encounter when using licensed vehicles. Responses can be kept anonymous if requested. They would like to hear from you as soon as possible but preferably before the end of March 2016. Blue Badge con: Warning to Plymouth disabled people

DISABLED drivers are being warned of a Blue Badge scam which has tricked at least one city motorist out of cash. Plymouth City Council is warning Blue Badge applicants and holders to beware of websites charging for help with their application or renewal.

One resident paid £49 for help filling out a Blue Badge form.

Councillor Brian Vincent said: “If you are renewing or applying for a Blue Badge you can do this directly with the council. You do not need to use other organisations’ websites. Our staff will give you all the help you need – for free. The only payment you will be asked to make is the standard fee of £10, to cover the cost of the badge.”

Some members may have seen PADAN Trustee, Bruce Abbott, interviewed about Blue Badge abuse on BBC Spotlight recently.

Councils in England took legal action against 985 people last year compared with 535 the year before. The majority were for using someone else's Blue Badge and this misuse attracts fines of up to £1,000 plus additional penalties for related parking offences.

Disability groups said they hoped legitimate holders of Blue Badges would be treated fairly by fellow motorists.

Badge thefts have risen to 2,056 cases, 300 more than the previous year.

'Toy Like Me' Campaign



Last year a social media campaign, **#ToyLikeMe**, was initiated by Rebecca Atkinson, a journalist who has a hearing impairment, and two mothers with disabled children to “increase diversity in the toybox”.

Rebecca has spent nearly 20 years working in TV production and print journalism (including Children’s BBC).

Campaigning for toys that represent diversity better is not new, but the ‘digital age’ is and it is social media that has made this campaign so successful.

With the exception of medicalised doctors’ and nurses’ kits, which began to feature during the 1940s, an analysis of 1930-1963 Billy and Ruth toy catalogues revealed an absence of disability-themed toys until a Three Blind Mice Talking Toy in 1955. The next to appear was Mr Magoo Toy Car in 1961, protested against by people with a visual impairment for stereotyping blindness. Disabled action figures J. Jay Armes (Ideal Toys, 1976) and Mike Power Atomic Man (G.I. Joe, 1975) were released as returning Vietnam vets were advocating for a more disability-inclusive society. Mattel Barbie’s Share a Smile Becky (1996) and American Sign Language Teacher (1999) followed the Americans with Disabilities Act (1990).

Ironically, Share a Smile Becky did not fit through the doors of Barbie’s Dreamhouse.

Following the **#ToyLikeMe** campaign Lego has revealed its first young disabled mini-figure and British toymaker Makies has released a line of dolls with disabilities using 3D printing.

#ToyLikeMe campaigners said that Lego was "pandering to disability stereotypes" because its only character to use a wheelchair was an elderly man. Other major toy manufacturers are now being urged to follow in the footsteps of the Danish firm.
